Hi Mary Sue,

Great to hear from you, I hope it's not too wet in your area!

Cities have a lot of options when it comes to forming its own economic development group or participating in an "outside" agency. From what I see, most smaller and medium size communities belong to an outside group, including some regional ones that serve a wider area (typically with a handful of cities involved). It's pretty common for these groups to form as a nonprofit public entity, which requires them to officially file with the IRS and lowa Secretary of State, as that gives taxexempt status.

I think the big thing early on for the city is to figure out who might be interested in participating in a economic development commission. In a lot of cases, chamber of commerce folks would be interested given the overlapping missions. You may also receive interested from individual businesses, developers and residents that want to support local economic development efforts. In addition, it's usually a good idea to contact the local school board and county supervisors to gauge their interest.

From there, you likely will get a better understanding of local interest and that will help determine what type of organization makes the most sense. Again, most cities belong as a member to an outside economic development commission, but in some cases it's truly a city-run organization. So you can see one nearby example, I've included the bylaws from Polk City's economic development corporation.

As far as getting some help, you're right that Jeff Schott has retired and the Institute of Public Affairs at UI is now closed (which is shame in its own right, but especially in this case as that is who I would've referenced). However, many of the services the Institute provided were transferred to ISU Extension, so it may be worth contacting Eric Christianson to see what they can offer: eichr@iastate.edu; (515) 294-8397.
