UNAPPROVED MINUTES Earlham City Council Meeting June 10, 2019

The Earlham City Council met in regular session on Monday, June 10, 2019, at Earlham City Hall. Mayor Lillie called the meeting to order at 7:00 p.m., and the following answered roll: Griswold, Fredericksen, Payne, Petersen, Swalla. Staff present: Clerk Hibbs, Police Chief Heimdal, Public Works Superintendent Coffman.

5. Department Reports

a. Public Works - Gary Coffman, Public Works Supervisor

Mowing & trimming; cemetery work; pool is up and running – had to buy new pump for heater; park shelter has been painted; tree trimmers in town; street sweeper has been running; Gendler mowed – problem with muskrats at the west pond; Library roof is leaking but he hasn't been able to find. The gravel road to the used by trucks to get to gravel pit is in terrible shape. Trucks are going out of their way and coming through town, on the truck route, to avoid it. Gary said our streets weren't meant for that much heavy traffic. He will contact the Madison County Secondary Roads Supervisor to encourage them to fix their road.

b. Police - Police Chief Jason Heimdal

There have been two concerts in the park and there have been no problems. They have been done by 9:00 p.m. Had one noise complaint. He went to Todd Brown retirement party and met the new emergency management director. Spoke with attorney Braland regarding regulating truck traffic on Birch. Sam said he believed we covered by state code and we did not need to change our ordinances. Clerk Hibbs interjected she talked with Braland who asked how the new ordinance was coming. Hibbs will check with Braland for clarification.

6. OLD BUSINESS

a. Sale of Old Fire Station

Hibbs stated the new ad has not been placed yet. Will do this soon.

b. Water Tower – Shive Hattery.

No one present from Shive-Hattery. Coffman stated design is on hold as they are considering moving the tower to different sight.

b. 2019 Freedom Fest request – Trent Lilly

All plans will be same as last year: Street Dance on July 3rd; parade, fireworks and all other events on July 4th. Requested no cars be allowed to park around the square. Parade route will be the same. Requested same materials for street dance as before (fencing, etc). Will have a DJ this year instead of band. Trent requested maybe another power source in park because when vendors use generators the noise makes it unenjoyable. Trent will talk w/Vendors this year about their generators and what kind of hookup they need. Mayor said maybe we make adaptable extension cords. Mayor/council agreed the DJ can still plug into the old master Griller Building. Freedom Fest Committee donated money for painting the shelter and restrooms at the park. Would like to continue using funds for this type of purpose.

Motion by Payne, second by Petersen, to approve the plans and requests from the Freedom Fest Committee.

c. Consider approval of agreement between City of Earlham and Faller, Kincheloe & Co PLC for annual examination services.

Motion by Fredericksen, second by Griswold, to approve motion to approve agreement between City of Earlham and Faller, Kincheloe & Co POC for annual examination services.

- d. Presentation of proposed Eagle Scout Project Garion Brown Graion's project consist of two signs at the cemetery, one each at the north and east entrances. The sign would state the cemetery rules. The current sign is on the shed which is being taken down. The sign will be on wooden post with metal below ground. He has talked with school to help with the metal sign. It will be 6-7 feet tall. He also offered to add the missing "M" on the arch. Coffman stated the fence is being taken out, including the arch with the missing "M". Coffman said he thought this was a good idea, and suggested Garion not put anything up until the fence comes out. Consensus of council, felt this was a worthy project. Mayor Lillie agreed and thanked Garion for his presentation.
- e. Discussion and possible action on dog owned by Cicily Hook.

 Amy Willem described an attack on her Australian shepherd, which took place on Thursday, June 6th, at 1st Street and Plum Avenue by a black labrador retriever, owned by Cicily Hook, 125 NE Plum Avenue, Earlham. Due to miscommunication between city hall and the police department, the owner of the black labrador, who attached the Willem dog, was not present. After listening to the description of the attack, and looking at pictures of the shepherd taken by the veterinarian immediately following the attack, the consensus of the Council is that the black lab is determined to be a "vicious dog".

8. Mayor's Report

Mayor reported on RAGBRAI preparations. Stated they could use more vendors. There is a meeting with State Health Inspector on Wednesday night to discuss cooked food, etc. Coffman asked what the public works department is supposed to do. City is in charge of barricades at intersections.
